

EDITORIAL & PERSONAL USE LICENSE AGREEMENT

Editorial/Personal Tier — Seattle Yacht Media

This Editorial & Personal Use License Agreement ("Agreement") is entered into as of the date of purchase ("Effective Date") between Seattle Yacht Media ("Licensor"), and the purchasing party ("Licensee"). The purchasing party is identified by the account, email address, and transaction record associated with the purchase of this license. Completion of the purchase transaction constitutes Licensee's acceptance of all terms herein.

1. DEFINITIONS

"Licensed Image" means the specific photograph(s) licensed to Licensee as identified in the purchase transaction.

"Editorial Use" means use in news reporting, commentary, criticism, education, documentary, or informational content where the image illustrates a factual subject and is not used to promote a product, service, or organization commercially.

"Personal Use" means use for private, non-commercial purposes by Licensee, not distributed publicly for commercial gain.

2. GRANT OF LICENSE

Subject to the terms of this Agreement, Licensor grants Licensee a limited, non-exclusive, non-transferable, non-sublicensable, perpetual license to use the Licensed Image for Editorial and Personal Use only.

2.1 Permitted Uses

- Editorial publication in blogs, news sites, magazines, or journalism (non-commercial context)
- Personal print use including framing, home display, and personal photo books
- Educational or documentary presentations and materials
- Non-commercial social media sharing with attribution
- Personal website or portfolio use where no commercial transaction is involved

2.2 Scope

Exclusivity: Non-exclusive

Territory: Worldwide

Duration: Perpetual

Authorized Users: Single party (Licensee only)

Media Types: Digital, Print, Editorial

Commercial Use: Not permitted under this tier

3. RESTRICTIONS

This license expressly prohibits:

- Any commercial use, including use in advertising, marketing, or promotional materials
- Use in connection with the sale of any product, service, or organization
- Transfer, assignment, or sublicensing to any third party
- Resale or redistribution of the Licensed Image in any form

- Use in print-on-demand merchandise, physical goods for resale, or templates sold to others
- Use that implies endorsement of a product, service, political position, or organization
- Use in any defamatory, misleading, obscene, or unlawful manner
- Removing or altering embedded metadata or copyright information

4. ATTRIBUTION

When used in editorial contexts, Licensee should provide attribution as follows: "Photo: Seattle Yacht Media" or "© Seattle Yacht Media." Attribution is encouraged but not strictly required for personal use.

5. INTELLECTUAL PROPERTY

All rights, title, and interest in and to the Licensed Image remain exclusively with Licensor. This Agreement grants a limited right of use only and does not transfer any copyright or ownership interest. Licensor retains the right to license the same image to other parties.

6. WARRANTIES AND REPRESENTATIONS

6.1 Licensor Represents:

- Licensor owns or controls all rights necessary to grant this license
- The Licensed Image does not, to Licensor's knowledge, infringe any third-party intellectual property rights
- The Licensed Image does not contain identifiable persons requiring model releases

6.2 Licensee Represents:

- Licensee will use the Licensed Image solely within the permitted uses defined herein
- Licensee's use will not be commercial in nature

7. LIMITATION OF LIABILITY

LICENSOR'S TOTAL LIABILITY TO LICENSEE FOR ANY CLAIM ARISING UNDER THIS AGREEMENT SHALL NOT EXCEED THE TOTAL FEES PAID BY LICENSEE FOR THE APPLICABLE LICENSED IMAGE. IN NO EVENT SHALL LICENSOR BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

8. INDEMNIFICATION

Licensee shall defend, indemnify, and hold harmless Licensor from and against any claims, damages, losses, and expenses arising from: (a) Licensee's use of the Licensed Image outside the permitted uses; (b) any breach of this Agreement by Licensee; or (c) any third-party claim arising from Licensee's use.

9. TERMINATION

Notwithstanding the perpetual nature of this license, Licensor may terminate this Agreement upon written notice if Licensee materially breaches its terms and fails to cure such breach within ten (10) days. Upon termination, Licensee must immediately cease all use of the Licensed Image.

10. GOVERNING LAW

This Agreement is governed by the laws of the State of Washington. Disputes shall be resolved in the state or federal courts of King County, Washington.

11. GENERAL PROVISIONS

This Agreement is the entire agreement between the parties regarding the Licensed Image. Licensor reserves the right to update these terms with thirty (30) days' notice. If any provision is unenforceable, the remainder continues in effect.
